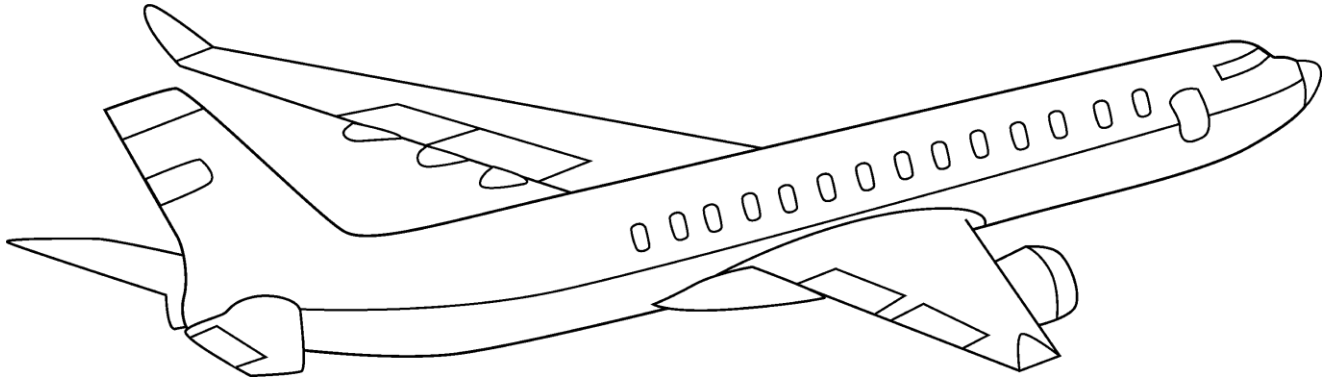


The United Faculty of Florida will distribute six

\$ 500 Travel Scholarships

to UFF (USF System) members for professional travel - e.g. to attend and present at a professional meeting - in Summer or Fall 2019.



If you are a member of the United Faculty of Florida, are eligible to apply for \$ 500 in professional travel funds. If you are not a member, you can join UFF and apply for funding.

If you are a member, submit a 200 word proposal for travel during Summer or Fall 2019 by April 17. Be sure to include your name, title, address, the name of the event or place you intend to visit, and a brief description of its importance. Travel grants will only be granted for applicants who will participate in a professional activity.

Recipients must acknowledge partial support by UFF in presentations or papers, must write a short account of the research, scholarship, or creative work the grant helped support, for publication in the UFF USF Biweekly, and attend a UFF USF Chapter Meeting to be recognized.

Drawing will be held at the April 19 UFF USF Chapter Meeting. Winners will be notified that weekend! Submit travel proposals to UFF - USF Membership, 30238 USF Holly Drive, University of South Florida, by Campus Mail, or to the Chapter Secretary via uff@ourusf.org.

IF YOU ARE NOT A MEMBER, you still can participate: anyone who joins by April 17 is eligible to apply. On the reverse side is a membership form. Join the movement.

Small print: Each recipient must wait three terms after an award before becoming eligible to apply again. UFF USF Executive Committee members are ineligible.
