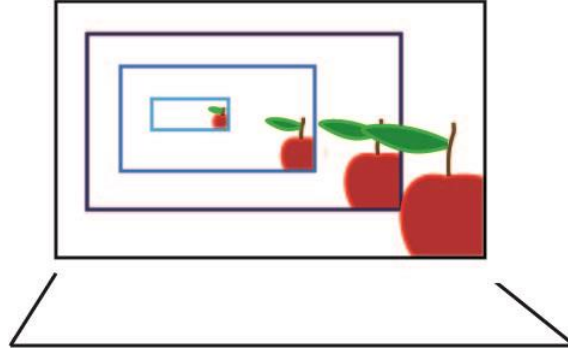


The United Faculty of Florida will distribute six
\$ 500 Research & Instruction Scholarships

to UFF (USF System) members for equipment, materials, and other professional expenses during this calendar year



If you are a member of the United Faculty of Florida, YOU are eligible to apply for \$ 500 in professional research and instruction funds. If you are not a member, you can join UFF and apply for funding.

If you are a member, submit a 200 word proposal for a professional activity occurring during Spring 2020, or Summer 2020, or Fall 2020 by May 6. Be sure to include your name, title, address, and the professional activity that the scholarship will help support. Scholarships will only be granted for applicants who will participate in a professional activity.

Recipients must acknowledge partial support by UFF in presentations or papers, must write a short account of the research, scholarship, creative work, instruction, or service the grant helped support, for publication in the UFF USF Biweekly, and must attend a UFF USF Chapter Meeting to be recognized.

Drawing will be held at the May 8 UFF USF Chapter Meeting. Winners will be notified that weekend! Submit travel proposals to the Chapter Secretary via uff@ourusf.org.

IF YOU ARE NOT A MEMBER, you still can participate: anyone who joins by May 6 is eligible to apply. On the reverse side is a membership form. Join the movement.

Small print: Each recipient must wait three terms *after* receiving a scholarship before becoming eligible to apply again. UFF USF Executive Committee members are ineligible. One scholarship is reserved for instructors.
